Additional Specifications

This system is designed to treat cold water only. The installation must be on a cold water supply.

Do not use with water that is microbiologically unsafe or of unknown quality without adequate disinfection before or after the system. Systems certified for cyst reduction may be used on disinfected waters that contain filterable cysts.

This system must be installed in accordance with all applicable state and local laws and regulations.

This system must be installed in an area not affected by extreme heat, cold or the elements. The selected installation area must be adequate for easy service of all parts.

The equipment needs to be installed to operate at the specified maximum flowrate.

Installation and Operation Guide

The $H_2Optimo$ EZ -Tap Commercial Hospitality Filtration System has be designed for ease of installation and maintenance. Once installed, components designed to be periodically replaced are easily accessible. The $H_2Optimo$ EZ -Tap Commercial Hospitality Filtration System is shipped from the factory partially assembled for ease of installation and to provide the best protection against shipping damage.

You Have Received the Following

1. One pre-assembled header assembly, consisting of the following items.

- a. One head assembly and bracket.
- b. One filter cartridge: See table on page 7 for replacement part numbers.

Selecting a Mounting Location

1. Give Consideration to the weight of the unit when operating filled with water. Operating weights of the $H_2Optimo$ EZ- Tap Commercial Hospitality Filtration Systems are shown in the table.

2. The location should allow for the following:

- Minimum clearance of 3" under the cartridge for easy cartridge replacement.
- Adequate space for "in" and "out" water line connections.
- Close to a drain for flushing of the system and new cartridges. (See figures 1 for mounting dimensions)




BACK VIEW WITHOUT CARTRIDGE




RIGHT SIDE VIEW

Installation

- 1. Use the predrilled mounting holes in the manifold bracket as a guide. Mark and drill the anchor holes. Mount securely using proper anchors (see figures 1).
- 2. Shut off incoming water supply.
- Shut off power to foodservice equipment, if applicable. 3.
- 4. Connect inlet and outlet ports of the H2Optimo EZ-Tap Commercial Hospitality Filtration System using NSF approved 3/8 tubing. (See Push In tubing connection instruction on page 7) Do not connect outlet port to food service equipment until after flushing (Step 8).
- 5. Install a manual shut-off valve leading to the system for servicing.
- 6. Install only genuine H₂Optimo EZ -Tap cartridge into the filter head following the directions on the cartridge label (see Fig 2).
- 7. Connect a piece of 3/8" tubing to the outlet port and run to a drain or bucket.
- Turn on the inlet water and flush the cartridge by running water 8. through at full force for 10 minutes. This will purge any air and fines from the cartridge.
- 9. Turn off inlet water. Connect 3/8" tube from outlet to food service equipment.
- 10. Turn on the inlet water to the filter system to check for leaks.
- 11 Restore power to the foodservice equipment.
- 12. The system is now ready for operation.

Important Note: Lubricate o-ring with a good food grade silicon lubricant prior installing to the filter filter head.



ALIGNMENT POINT IS LOCATED ON THE LEFT (BY INLET)


Push-IN Tubing Connection:


For push in tubing connections, follow the instruction below to be sure that the tube is properly installed in the fitting:

• Slightly lubricate the tube with silicon before pushing into the fitting. Push tube straight past o-ring till tube stops (See fig 3).


Cartridge Change Determination

Replace the cartridge when the gallon capacity is reached or when the flow becomes inadequate.


Follow this procedure to change the EZ-Tap cartridge:

- 1. Shut off power to the foodservice equipment, if applicable.
- 2. Shut off the incoming water supply.
- 3. Remove cartridge from head as shown in Figure 4. A small amount of water will spill, so you may want to place a towel under the unit.
- 4. Install the new cartridge, following the procedure shown in Figure 2.
- 5. Disconnect the tube on the outlet port.
- 6. Connect a piece of 3/8" tubing from the outlet port to a drain or bucket.
- 7. Turn on the inlet water and flush the cartridge by running water through at full force for 10 minutes. This will purge any air and fines from the cartridge.
- 8. Turn off inlet water. Reconnect tubing between outlet port and food service equipment. NOTE: Tubing may become scratched after repeated insertion. Check the end of the tubing. If damaged, trim about 1" off to get a clean end for proper sealing.
- 9. Turn on the inlet water and check for leaks.
- 10. Restore power to the foodservice equipment.

THE FILTER CARTRIDGE IS WARRANTED AGAINST DEFECTS IN MANUFACTURE FOR A PERIOD OF ONE (1) YEAR.THE FILTER CARTRIDGE SERVICE LIFE IS DEPENDENT ON SPECIFIC WATER CONDI-TIONS AND USAGES. REFER TO THE INSTALLATION AND OPERATION GUIDE FOR RECOMMENDED REPLACEMENT FREQUENCY.
